Sub: Fresh Composite Provisional Affiliation to the above said school upto Secondary level.

Sir/Madam,

With reference to your application dated 28.06.2005 and subsequent correspondence/inspection, I am directed to convey the sanction for Provisional/Composite Provisional Affiliation for Secondary School Examination of the Board for a period of three years w.e.f. 1.4.2007 to 31.3.2010.

The above sanction is subject to the fulfillment of the following conditions:

1. The school will follow the syllabus on the basis of curriculum prescribed by NCERT for the Middle Classes.
2. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and changes made therein from time to time
3. The school shall appoint only qualified and eligible staff.
4. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school premises and furniture at its disposal for holding its examinations free of charges if required
5. The school will spare sufficient teachers, for invigilation purpose at the examinations of the Board, as may be required
6. The school will spare its teachers for evaluation of answer-books for the Board's examinations, if required.
7. The school will provide Laboratories, Library and other facilities as per norms of the Board
8. The school will abide itself by the conditions of affiliation already prescribed by the State Government concerned.
9. Service agreement be executed with the staff as per norms generally accepted by the State Government concerned.
10. Service conditions pay and allowance and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.
11. The school and its records shall be opened for inspection by an officer/official of the Board or an authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time
12. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.
13. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.

14. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
15. The School will not sponsor candidates for Board's examination of any other School/Branch, which is not affiliated.
16. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws/Rules of the Directorate of Education, Delhi in the joint names.
17. The school should not start Class XI/XII without written approval of the Board. The Board shall not be responsible on every consequences in case class XI/XII is started without following the Affiliation Bye Laws and obtaining the prior approval of the Board.
18. The affiliation Code Number allotted to your school is 2730539. This may please be noted and quoted for any correspondence with the Board.
19. Annual fee of Rs. 4500/- @ Rs.1500/- per annum for three years w.e.f. 1.04.2007 to 31.03.2010 be also remitted at an early date.
20. The school should apply for further Extension of Provisional Affiliation before 30th June of the preceding year before the expiry of the date of Affiliation 'On Line' through CBSE Website www.cbseaff.nic.in or www.cbse.nic.in and send a copy of its confirmation page with prescribed fee of Rs. 12,500/- in the shape of Bank Draft drawn in favour of Secretary, CBSE, Delhi.
21. Renewal of Registration of Society be ensured.
22. "The school will be eligible to open CBSE pattern class IX w.e.f. the session 1.4.2007 Accordingly 1st Batch of class X of the school will be appearing at the CBSE Examination to be held in the year 2009.
23. Other conditions are as per Annexure 'A' enclosed.

Conditions for immediate compliance:

1. The school is required to submit Building Completion Certificate
2. The area earmarked as playground is not sufficient and not developed properly hence the school is required to develop the playfield and submit the report of the same
3. The size of classrooms is small measuring 340 sq mtrs approximately. Therefore the school is required to restrict the number of students in each class by providing 1sq.mtr floor area per child. The school should have more sufficient big rooms for opening class IX and more qualified teachers should be appointed on regular basis as per norms of the Affiliation Bye-laws of the Board.
4. The school should introduce EPF facilities to the staff.
5. The school is advised to send its teachers for in-service refresher/orientation programmes to update their knowledge and teaching skills to improve their present methodology of teaching and academic wing.
6. The school is required to add more equipments/apparatus in Science lab
7. The library may be enriched by adding meaningful /quality books
8. The school is also advised to follow service rules properly and all the stock registers of sports Science lab, library, computer and Sports, Books of Accounts, Administration records, Service Books and personal files, Admission and withdrawal Register etc. may be updated and countersigned by the Principal and Manager of the school wherever applicable.


